




Foreword to the Post-Qualifying Social Work Practice series

Her professional experience includes residential work in a girls' remand centre, a Rudolph Steiner School and a hostel for children with learning disabilities, as well as generic fieldwork in the West Riding of Yorkshire and ten years in Sheffield. She is currently senior social worker in a children in care team in Cornwall, where she has worked with children and families since 1988.

Yvonne Mieville is an experienced social worker working for Dorset County Council. She completed her Post-Qualifying Child Care Award in 2008 and is currently pursuing her studies at master's level. She plans to undertake a PhD in the future.

Steven Mills is an experienced social worker, currently working for Bournemouth Borough Council. Steven completed his Post-Qualifying Child Care Award in 2009.

Liz Reilly qualified as a social worker in 1999 after completing a graduate course in social work at the University of Bristol. She also completed a master's in Social Work at the same university, graduating in 2000. Before, during and after qualifying she worked with young people 'in and leaving care', and in various levels of supported and semi-independent living. In particular, she worked as a social worker and a deputy manager for North Somerset Council's Leaving Care Service. Since October 2008, Liz has been studying for the Post-Qualifying Specialist Child Care Award and, at the same time, is working as a social worker in an assessment team. Other interests include community-based social work, Family Group Conference models of engaging families and, more recently, about the development of social work as a technical activity.

Hilary Schultess-Young qualified 13 years ago and has practised in Cornwall County Council's Social Care Department since that time. She has held a number of posts in children's services including Youth Offending, Access and Assessment and, as a specialist worker, with Gypsies and Travellers. Hilary is currently a specialist Hidden Harm social worker, piloting a project for the local authority which provides intensive intervention work with families and addresses parental substance use issues and their impact upon children and young people subject to a child protection plan or in care.

Trevor Thomas qualified as a social worker in 1988 and started his practice as a deputy social worker for Worcester County Council where he gained invaluable experience in child protection. In 2003, Trevor relocated to the then North Cornwall children's team, working across access and assessment as well as working with long-term cases. Upon completion of the Post-Qualifying Child Care Award, Trevor became practice manager within his team with responsibilities for access and assessment. Trevor now works as an independent reviewing manager for Cornwall County Council, reviewing the cases of children in care and chairing child protection conferences.

Andrea Wilkinson has been a qualified social worker for the last seven years. She started her social work career working in adult social care which, prior to 2005, met the needs of both adults and children with learning disabilities in Cornwall. She worked predominantly with disabled children, children with complex needs and children with life-limiting illnesses at this time. In 2005, Disabled Children in Cornwall became part of children's services and children no longer had their needs met within adult teams. Instead, Community Support Teams were formed to meet the needs of children with disabilities. Andrea is due to take up a new role within Children, Schools and Families Services in Cornwall in the post of Senior Social Worker Disability Lead in the access and assessment team.
