INTRODUCTORY NOTES

COALITION CANDIDATES 1918-1922 In the majority of tables, official Coalition candidates are not distinguished from other candidates of the same party. The only exception is in respect of the five Coalition Labour candidates at the General Election of 1918 who could not be classed with other Labour candidates as they were not endorsed by the Labour Party. The Coalition prefix has only been used for official candidates of the Coalition, i. e. those who received the 'coupon', a letter signed by Lloyd George and Bonar Law which was sent to approved nominees.

CO-OPERATIVE PARTY From the General Election of 1922, all Co-operative Party candidates have been endorsed by the Labour Party and sought election as 'Labour and Co-operative'. No distinction is made in the tables between these joint candidates and other Labour candidates.

ELECTORATE As a result of the Representation of the People Act, 1969, those becoming 18 years of age during the period covered by the annual Electoral Register now have the date on which they attain their 18th birthday inserted in the Register and they can vote from that date. This change in the registration procedure meant that it was no longer possible to know the exact electorate in a constituency on a particular date without asking Electoral Registration Officers to go through each register and deduct the number of post-election "dated names" from the total electorate. Before the widespread use of computers this was a laborious task which caused delays in the obtaining of electorate figures and frequently resulted in Electoral Registration Officers providing estimated rather than exact figures.

In 1974, Parliamentary Research Services initiated discussions with the Office of Population Censuses and Surveys, the Home Office, the Press Association, the British Broadcasting Corporation, Independent Television News and a number of interested academics in an attempt to find an acceptable formula for calculating electorates on a particular date. As a result the following formula was used by the media in calculating the electorate from the General Election of October 1974:

Total number of "dated names" on the Register multiplied by the fraction

Number of days from February 17 to Polling Day (both dates inclusive)

364 (or 365 in a Leap Year)

The following is an example of the calculation:-

Electorate at 16 February	64,162
Number of "dated names"	757
Total	64,919

Using the Electorate Calculator on page 118 and assuming polling day was October 1 the formula would be:

 $757 \times 227/364 (0.623626) = 472.084882 (truncate)$

The estimated electorate at October 1 would be:

64,162 + 472 = 64,634

The figures for electorate given in this book for General Elections and subsequent byelections from 1974 have been calculated using the above formula. For the general elections of 1992 and 1997 an increasing number of Electoral Registration Officers were able to provide exact figures of the electorate 'on the day'. These have been used where available.

The number of electors is, of course, affected not merely by 'coming of age', but by death, moving house, submitting late claims for inclusion etc. An earlier edition of this book attempted to take account of these factors in calculating an 'adjusted' turnout figure. The formula is outlined in detail in F.W.S. Craig, *British Parliamentary Election Statistics 1918-1970* (Chichester, 1971) and in the chapter on Britain in R. Rose (ed), *Comparative Electoral Behaviour* (New York: Free Press, 1972). An indication of its impact on general election turnout for the period 1950-1997 can be found in Table 4.02.

GAINS AND LOSSES Until 1992 a gain or loss of a seat has been recorded on the basis of the incumbent's party allegiance at the time of the Dissolution or by-election. This means that where an MP changed from one party to another or became an Independent during a Parliament and did not resign immediately, his seat was from then on considered to be held by his new party. From 1992 gains and losses are calculated by reference to the previous general election result. A detailed list of changes of party allegiance since 1900 will be found in David Butler and Gareth Butler, Twentieth Century British Political Facts, 8th edition (London: Macmillan 2000) pp. 244-249.

INDEPENDENT LABOUR PARTY From 1900 until August 1932, the Independent Labour Party (ILP) was affiliated to the Labour Party and as their candidates normally received endorsement they are treated as official Labour candidates in the tables. There were however four by-elections where ILP candidates went forward without Labour Party endorsement and they have therefore been classed as ILP and not Labour candidates.

INDEPENDENTS AND MINOR PARTIES The columns headed 'Others' include all Independents and candidates of minor parties and organisations.

LIBERALS AND NATIONAL LIBERALS 1922-1923 In the majority of tables, no distinction is made between (Asquith) Liberal and (Lloyd George) National Liberal candidates. The two groups merged in November 1923 to fight the forthcoming General Election as a united party.

LIBERAL/SOCIAL DEMOCRATIC PARTY ALLIANCE These two parties concluded an electoral alliance for the general elections of 1983 and 1987. Summary information covering the performance of both parties at those elections, and at other types of election from 1982-87 inclusive, is usually aggregated under the 'Liberal' heading.

MULTI-MEMBER SEATS Percentage figures of votes cast and turnout have been adjusted to allow for the multi-member seats which existed prior to 1950. In calculating the percentage of votes, the total votes in multi-member constituencies have been divided by the number of votes which each elector was allowed. In two-member seats each elector had two votes; in three member constituencies prior to 1868 each elector had three votes but from 1868 this was reduced to two votes; in the four-member constituency of the City of London, prior to 1868 each elector had four votes but this was reduced to three votes from 1868.

In calculating turnout prior to 1885, votes in multi-member seats have been counted as one quarter, one third or one half votes which makes no allowance for electors using fewer than the votes allowed to them. The turnout percentages produced are therefore a slight underestimate of the number of electors voting as distinct from the number of votes cast. From 1885 onwards figures of the actual number of electors voting in multi-member seats were, with a few exceptions, generally available and have been used in calculating the turnout.

NATIONAL LIBERAL AND CONSERVATIVE CANDIDATES In the majority of tables, no distinction is made between joint National Liberal and Conservative candidates and other Conservative candidates. In May 1947, recommendations were issued by Lord Woolton, on behalf of the Conservative Party, and Lord Teviot, on behalf of the National Liberal Organisation, which advocated that the two parties should come together in constituencies and form combined associations under a mutually agreed title. Immediately following the 1950 election, a Liberal-Unionist Group was formed in the House of Commons by those MPs elected under the auspices of joint local associations. Owing to local circumstances and preferences, the actual 'labels' used by candidates varied from one constituency to another but for the sake of uniformity the designation National Liberal and Conservative (NL & C) has been used throughout this book. In May 1968 the National Liberal Council was disbanded.

NORTHERN IRELAND Until the General Election of February 1974, no distinction has been made between Unionist, Labour (provided they were endorsed by the Labour Party in London) and Liberal candidates in Northern Ireland and Conservative/Unionist, Labour and Liberal candidates in Great Britain.

From the General Election of February 1974, candidates of the Ulster Unionist Council, Northern Ireland Labour Party and the Ulster Liberal Party have been classed as 'Others' in all the tables. This reflected the changed political situation in Northern Ireland which made it unrealistic to continue the former method of classification.

NOTIONAL RESULTS Occasionally reference is made to the 'notional results' of the 1992 general election. This means that the data are taken from an exercise conducted on behalf of the BBC, ITN, PA News and Sky News to estimate the likely result in each constituency in 1992 if the new, 1997 boundaries had then been in place. This allows a comparison to be made between the 1992 and 1997 results at constituency level. Full details can be found in C. Rallings and M. Thrasher (eds.), Media Guide to the New Parliamentary Constituencies (Plymouth: Local Government Chronicle Elections Centre, 1995).

PERCENTAGES F. W.S. Craig tried to ensure that the percentages in his tables summed to 100. In the tables we have compiled percentages do not always sum exactly to 100 because we have adopted the more conventional approach of rounding figures originally calculated to 2 or more decimal places.

SOURCES Unless otherwise stated, all statistics have been compiled from British Parliamentary Election Results, 1832-1983 (5 volumes) compiled and edited by F.W.S. Craig, and from British Parliamentary Election Results 1983-97 and Britain Votes 6 compiled and edited by Colin Rallings and Michael Thrasher. Statistics relating to elections in Ireland from 1832-1922 for which detailed constituency results are not included in British Parliamentary Election Results have been based on Dr Brian Walker's book Parliamentary Election Results in Ireland 1801-1922.

SPEAKER OF THE HOUSE OF COMMONS The Speaker of the House of Commons takes no active part in an election campaign and since 1950 (when the Speaker requested that he be given no party 'label') has sought re-election as 'The Speaker' and not as a party candidate. Until 1997 the Speaker has been regarded as a candidate of the party he represented before his appointment. For the 1997 general election the votes cast for the Speaker are included among 'Others'.

STATE OF PARTIES AFTER GENERAL ELECTIONS Throughout this book the state of parties in the House of Commons following a General Election reflects the position after the double and treble elections had been decided but prior to changes caused by election petitions.

SWING 'Swing' is a way of summarising the change in share of the vote between two parties at two points in time. In Table 2.08 two measures of swing are used. Two-party ('Steed') swing is a measure of the change in the percentage share of the vote for the Conservative and Labour parties in terms of the votes cast for those two parties only. Total vote ('Butler') swing measures the change in terms of each party's percentage share of the total votes cast at each election. A fuller explanation may be found in D. Denver, *Elections and Voting Behaviour in Britain* (London: Prentice Hall, 1994) pp.19-20.
