Abandon Ship An order, usually only given verbally by the master, for all personnel on a vessel to leave it during an emergency.

Abandon Ship Ladder A rope ladder used either with the lifeboats or the sides of the ship in the event of abandoning a ship while in distress. *Abbrev.* A.S.L.

Acceleration Increase of speed, rate of change of velocity (e.g. of an aircraft).

Acceleration Acceptance During the initial stages of a business deal offers or counter offers are exchanged between the prospective buyers, the sellers and, on some occasions, by the brokers. If agreement is reached that would lead to the introduction for the approval of the contract. *Abbrev.* ACP or A.C.P. or ACC or A.C.C. or acpt.

Accept/Except A terminology in the negotiations between a broker and an owner or principal accepting

certain points of the contract and at the same time deleting and/or altering others.

Acceptance or Accepting Houses Merchant bankers specialising and dealing in foreign trade transactions and possessing a high degree of experience in financial business affairs. One of their functions is the acceptance of Bill of Exchange, $q.\nu$, on behalf of customers for a nominal fee.

Acceptance Supra-Protest An acceptance for the sake of saving honour due to a protest such as: A protested Bill of Exchange, q.v., is accepted by another party so as to avoid dishonour to the drawee. See Accommodation Bill.

Acceptilation A legal Scottish term meaning the release from a debt.

Accepting Authority Senior naval officer or senior civilian contractor who is designated to deal on behalf of the government in accepting a naval ship USA.

Acceptor That person who has accepted liability of a Bill of Exchange, q.v. See Acceptance Supra-Protest, Accommodation Bill and Bill of Exchange.

ACCESS Air Canada Cargo Enquiry Service System; Name of a credit card used in the UK.

Accessories Clause A motor vehicle insurance clause. Accessories of a motor vehicle are not covered by the insurance unless the whole vehicle is stolen or lost.

Accident Insurance An insurance covering accidents while travelling by land, sea or air.

Accident Prevention Board or Bureau An American organisation established in San Francisco in 1927 devoted to the prevention of accidents involved in cargo handling operations. All accidents are studied and recommendations made to the Pacific Maritime Association. *Abbrev.* APB or A.P.B. See PMA.

Accidental Vanishing Point Any vanishing point in the perspective which is not in the Horizontal Line, i.e. the line drawn on the picture plane at eye level. *Abbrev.* AVP or A.V.P.

accom. Accommodation.

Accommodation Bill This is an endorsed Bill of Exchange $q.\nu$, to safeguard another party. The person signing it is holding himself responsible as guarantor if the other party does not pay at the proper time. Sometimes, though not very often, it is termed Kite. See Acceptance Supra-Protest.

Accommodation Ladder A Gangway, q.v., ladder with flat steps and handrails on either side enabling passengers and members of the ship's crew to embark or disembark. *Abbrev.* A.L.

Accommodation Party The person or company signing and accepting the Accommodation Bill, q.v.

Accomplished Bill of Lading The consignee presents the original Bill of Lading, *q.v.*, to the ship's agents duly endorsed which is then retained for record

purposes. This endorsed bill of lading is called 'accomplished'.

According to Customs of Port See Customary Despatch.

Account Arithmetical calculations; Statement of business transactions.

Account Current see Current Account.

Account Interest Accumulated Interest.

Account Payee Only or Acc. Payee Only A phrase on a crossed cheque meaning that it cannot be transferred by endorsement to an individual other than as named on the cheque.

Account Sales When merchandise is sent on consignment, credit or stock, the receiver or agent periodically (normally every month) gives a detailed account of the sales effected, including his commission and the remaining stock.

Account of Wages A full account of the ship's crew's wages including pension contribution, national insurance, holidays, allotments, withdrawals etc. The account of wages is signed by the crew and countersigned by the master.

Accountant A person engaged in book-keeping.

ACCP or A.C.C.P. American College of Chest Physicians.

Acc (Prop) Accident (Property) Department insurance.

accred Accredited.

Accrued Interests Accumulated interest on securities or interest due but still unpaid.

Acct. Account; Accountant.

ACCU Automatic Control Certified Unattended. It refers to Bridge control of an unmanned Engine Room.

Accumulative Hours A coal Charterparty, $q.\nu$, stipulation that allows extra time to the charterers for loading in the event that the vessel arrives after her expected date of readiness. *Also called* Hours Accumulative.

ACD Adaptive Compass Drive computer; Automatic Call Distributor telecommunications.

Active Debt A debt upon which interest is actually paid. See Passive Debt.

Active Market Certain types of popular Stocks and Shares, $q.\nu$, which are continually on the market.

Active Partner A shareholder in a company or a firm who participates in the running of the business for which service he is paid. If a partner or a shareholder does not take an active part he is called Dormant or Sleeping Partner, q.v.

Act of Bankruptcy When a firm or company becomes insolvent and is officially declared as such it publishes or declares an act of bankruptcy. By so doing its normal activities virtually come to a halt and the creditors start claiming moneys due through official or legal quarters. The procedure takes some time as the auditors in charge of the dissolution of the company, due to its insolvency, will have to assess the relative and proportional payment for each and every claim. Sometimes it is called Keeping House.

Act of God An inevitable event occurring without the intervention of man—such as flood, tempest, or death—operating in case of certain contracts, such as those of Insurers, $q.\nu$ or Carriers.

Act of Omission of Shipper or Owner of the Goods or Agents An excepted peril of the sea in the Carriage of Goods by Sea Act 1924, subsequently amended. The Carrier is exonerated from any consequences due to omission or carelessness on the part of the shippers or his/their agents.

Act of Public Enemies An excepted peril of the sea in the Carriage of Goods by Sea Act 1924, subsequently amended. This refers to an act of piracy.

Act of War An excepted peril of the sea in the Carriage of Goods by Sea Act 1924, subsequently amended, which includes wars of all nations. The nationality of the ship is immaterial.

Actual Total Loss *Abbrev.* ATL or A.T.L. This relates to an insurance policy and can occur in any of four ways: (1) The property is completely destroyed; (2) The owner is irretrievably deprived of the property; (3) Goods change their character to such a degree that they can be said to be no longer the thing insured by the policy; (4) The subject matter of the insurance, be it ship or goods on board the ship, is recorded as 'missing' at Lloyd's.

Actual Payload Net Weight. The difference between the gross weight and the Tare, q.v.

Age Admitted In life insurance (assurance) this clause refers to the actual age acceptance or admittance by the insurance company which requests a birth certificate or similar document to ascertain the age declared by the proposed assured.

Agency The right given by an individual or a body to another person or company to act on his or its behalf or to market or sell his or its products. An agency may be classified in three categories; (1) Specific or Special Agency where the duties are restricted to a nominated transaction. (2) General Agency where actions can be undertaken on behalf of the principals with a certain amount of responsibility. (3) Universal Agency which involves the full power of attorney provided all actions will be within the law. Agency appointments are normally given on the basis of a certain period of time or indefinitely by means of a written contract or a letter of intent. There is a wide scope in agency work such as (a) Representing a shipping company (b) Contracting agreements for the booking (or stemming) of ships for drydocking and/or repairing in the marine engineering, drydocking field (c) Personal representation on official matters in the absence of the principals (d) Importation of materials and/or products. *Abbrev.* Agy. See Agent.

Agency Commission Clause An insurance clause whereby the insurer will not reimburse the assured for expenses and time incurred in obtaining and supplying information and documents in support of a claim, nor any fees or commissions involved in doing so.

Agency Fee A remuneration allowed to an agent in a port by a shipowner for work performed during loading and/or discharging operations or any other agency work performed during the time that the vessel has entered and left the port. The agency fees vary in every port and official tariffs are invariably laid down by either the government or other authorities. There is also a very similar agency fee where the importer is allowed a certain percentage against the amount of the imported merchandise by the exporter or the manufacturer or his principal. This is termed as 'Commission Agency'. See also Commission Agent.

Agenda A pre-arranged list of business topic items, circulated to members for discussion when meetings are convened. The circulated papers are called the Agenda Papers.

Agent A person or a company authorised to act on behalf of his or its principal. The appointed agent is very important as he will be the man on the spot who has to act promptly and cautiously to deal with any problems on behalf of his principal. The agent is duty bound to follow the instructions of his principal very carefully and, in many instances, he indicates on whose authority he is acting. It is also common to find under the signature 'As Agent(s) Only' to signify in what capacity he is signing. There are many classes of representation involving agents, some of which are: Chartering Agent/Broker, Commission Agent, Distributing Agent, Forwarding Agent, Loading Agent, Operating Agent, Owner's Agent, Managing Owner, Master for the Owners, Ship Agents and others. It provides an extensive amount of information concerning air control, close direct communications, search and rescue and many other reconnaissance operations. This radar system has proved to be useful in the field of air safety and communications. *Abbrev.* AEWS or A.E.W.S. Also termed as Aircraft Early Warning System.

Airborne Radiation Thermometer An instrument working by radiation which measures ocean surface temperatures.

Air brake The aircraft speed brake.

Air Canada Canada International Airlines.

Air Carrier An aircraft carrying passengers, mails and cargo; Company involved in the air transportation of passengers and cargo.

AIRCAT Automated Integrated Radar Control for Air Traffic.

Aircoach A bus engaged on a regular schedule carrying air passengers to and from an airport.

Air Cock A safety valve normally placed on top of boilers or air cylinders to release extra air pressure.

AIRCOM Airways Communications System.

Air Control A section at or near to an airport which controls the whole operations of the flights at that airport and within its international air control area. It is also termed Air Control Centre or Air Control Center.

Air Control Centre or Air Control Center Similar to Air Control, q.v.

Air Controller A person engaged on land at the Air Control, $q.\nu$, who controls aircraft within his national and international area by means of radio, radar and other sophisticated electronic devices.

Air Corridors or Air Routes or Airways International air routes or channels specifically allotted to aircraft for their flights.

Aircraft Any kind of flying machine.

Aircraft Early Warning System See Airborne Early Warning and Control System.

Aircraft Report A routine weather report transmitted every hour to some stations by aircraft flying within the same area. *Abbrev.* AIREP.

Aircraft Surface Movement Indicator A radar screen in an airport control tower displaying all the movements of the aircraft within its area. *Abbrev.* ASMI.

Aircrew The personnel engaged to fly and operate the service from the time the passengers enter the aircraft up to the time they leave.

Air Cushion Craft Hovercraft, q.v.

Air Draft (Draught) (1) Air Ventilation (2) The height of a ship taken from the waterline to the top of the mast. This calculation is most important if the ship is meant to trade or navigate under bridges, especially along rivers. There are in fact certain river boats which have collapsible masts and also hydraulic bridges to allow them to be raised or lowered accordingly while navigating under bridges. See Low Profile vessels. (3) The distance between the waterline and the top of hatchcoamings on vessels which need to manoeuvre beneath shore loading or discharging apparatus—e.g. Panamax bulk carriers.

Airdrome or Aerodrome Similar to Airbase, q.v.

Airdrying Paints Paints which dry when exposed to air. These are conventional paints composed of various oils and chemicals.

Air Duct An air tube providing circulated fresh air in a mine by expelling the bad air.

Air Engine An engine actuated by heated air.

AIREP Aircraft Report, q.v.

Air Express Method of sending goods by fast air transportation; Express Airmail.

Air foil Rudder, wind or other device counteracting the moving airstream of an aircraft.

Air Frame The whole structural part of an aircraft less the engines.

Air freight Cargo sent by air.

Air Freighter An aircraft specially meant to carry air cargo.

Air Gauge Apparatus to measure air pressure.

Air Glow Radiant emission seen at high atmosphere during darkness and at lower areas at dawn.

Air Hostess Stewardess on an aircraft, serving the passengers during flight.

Air jacket Inflatable lifejacket of a buoyant type used in case of emergency in an aircraft. Each passenger and crew member on board is supplied with one.

Air Launch To launch from an aircraft, such as firing a missile.

Air Letter A light paper form supplied by Post Offices with an impressed stamp and easily folded into the form of a closed envelope. With its uniform stamp it can be posted to various countries abroad and is normally treated as an airmail letter.

Air lift Large scale air transport operation.

Airline Prefix Unique number allocated by IATA to each airline, which is applied to the beginning of an Air Waybill, *q.v.* Numbers issued by that airline.

Airliner A fairly large passenger aircraft flying to and fro on a scheduled service.

Airload All merchandise carried on an aircraft.

Airman's Information Manual A handbook or manual published by the Federal Agency of America providing general information on civil flights in the National Airspace System. *Abbrev.* AIM.

Airmic or AIRMIC Association of Insurance and Risk Managers in Industry and Commerce.

Air Pipe A pipe allowing air to escape from a ship's tank containing fuel, water or other liquid. It is connected from the top of the tank up to the deck or upper deck. *Also* **Vent Pipe**.

Airport Terminal base for passengers and aircraft. Similar to Landing Field, q.u.

Airport Handling Charges Charges levied by airlines for the handling of cargo carried by their aircraft.

Airport Insurance This is generally called for short Ariel, q.v.

Airport Tax A levy on boarding air passengers in some countries.

Air Post Airmail Letter.

Air Route/s Similar to Air Corridors, q.v.

Air Route Surveillance Radar or Airport Surveillance Radar A long-range air traffic control radar positioned at airports which records the location and bearing of aircraft as far as approximately 30 nautical miles. *Abbrev.* ARSV or ASR.

Air Scoop Device in front of an aircraft to suck in air during the flight. An air scoop is also used in some engines for engine cooling purposes.

Air/Sea Interchange Refers to merchandise which is partly despatched by air and partly by sea. Normally two documents are needed, an air waybill for the air despatch and a transhipment bill of lading for the sea freight.

Airscrew Aircraft propeller.

Air Sendings Air cargo in transit.

Airspeed Speed of aircraft considering air pressure which is different to the ground speed. There are three types of air speeds, i.e., Indicated Airspeed, $q.\nu$; Calibrated Airspeed, $q.\nu$, and True Airspeed, $q.\nu$

Airspeed Indicator An instrument marking the aircraft's speed in knots and Mach Number, q.v. Abbrev. ASI.

Airstop Helicopter passenger station.

Airstrip A runway on an airfield usually constructed of concrete.

Air Ticket Flight Coupon or Ticket.

Air Transport Method of transportation whereby goods and/or passengers are carried by air.

Air Transport Undertaking Legally defined as an undertaking whose business includes the carriage by air of passengers and cargo for valuable consideration.

Airwaybill or Air Waybill or Air Freight Bill A document similar to a Bill of Lading, $q.\nu$, but utilised for the transportation of merchandise by air freight. It shows the title of ownership and the details of goods being airfreighted, *Abbrev.* AWB or A.W.B. for Airwaybill or Air Waybill and AFB or A.F.B. for Air Freight Bill.

Airworthiness The general operational safety of an aircraft.

Allotment Note See Advance Note.

All Outside Cabin Concept A concept introduced by Finnish shipbuilders where all passenger cabins in a cruise liner have to obtain natural light. *Abbrev.* AOC.

All Purposes Voyage C/P Term This works in conjunction with Laytime, $q.\nu$, or Laydays, $q.\nu$, where loading and discharging are to be accounted for en block. Similar to All Purposes.

All Rights Reserved Book Publishers Copyright. Also expressed as Copyright Reserved.

All Risks An insurance term which means that the policy covers the insured property for loss caused by any fortuity. The policy does not cover inevitable loss.

All-Round-Light Nautical term for light showing unobscured through a horizontal of 360°.

All Round Price The price which covers the cost of the material and all the other extras over the basic price.

All-Terrain Vehicle Car designed to go on any rough road including bumpy and difficult fields. *Abbrev.* ATV.

All Time Saved A saving on the total time allowed for loading and/or discharging. The charterers are entitled to despatch money on all time saved, making due allowance for weekends, holidays and other charterparty exceptions. In a charter the expression is used in connection with Despatch Money or Dispatch Money, *q.v. Abbrev.* ATS or A.T.S.

All Told The total deadweight of the ship. This includes the full weight capacity of the holds, bunkers, spares, provisions, water, etc., on board.

Alluvium Very fine sand deposited in the bottom of running water.

All-Weather Air Stations Specific airports or air stations which have the means of Instrument Flight Rules (IFR) to clear private or single pilot aircraft on arrival. *Abbrev.* AWAS.

All Working Time Saved Similar to All time Saved but Laytime is calculated during working time only and not during Sundays/Saturdays and holidays.

Almanac A nautical book, published annually for seafarers and others giving useful and general information on many aspects including abbreviations, tides, weather, navigation, astronomy, etc.

Alnico Trade name for an alloy of alluminium, nickel, cobalt and iron. It is mostly used for magnets.

Aloft Above decks; On a mast or rigging. Nautical.

Alongside A common word used in contracts of affreightments regarding the delivery of the cargo both in loading and discharging. It protects the owner of the ship in case of any claims by the consignors and consignees of the cargo. Such cargo is at the charterer's risk and expense until lying within reach of the ship's tackle. Also, the position of a ship when she is securely moored on her berth in a port. *Abbrev.* A.S. or a/s or A/S. See Within Reach of Tackle.

Alongside Date The date by which the ship accepts the merchandise for loading.

Alternative Director A person appointed at a general meeting of a company to act as a director in lieu of another.

Alternative Dispute Resolution The settlement of contested claims by any means short of going to law i.e., arbitration, agreement or compromise.

Alternative Investment Market Opened by the Stock Exchange in 1996 for small, young and growing companies. *Abbrev.* AIM.

alterum tantum Latin—As much again; twice as much.

Altitude The angular distance of an object above the horizon, measured in navigation to assist in fixing a vessel's position. The instrument most commonly used for this purpose is the Sextant, *q.v. Abbrev.* alt or A/T.

Altitude Circle Parallel of altitude nautical.

Altimeter An aneroid barometer in an aircraft showing the altitude and the surface pressure.

Altocumulus Clouds White and/or grey patch, sheet or layer of clouds, composed of laminae or rather flattened globular masses, the smallest elements of the regularly arranged layer being fairly small and thin, with or without shading. They appear between 6,500 and 18,000 ft. approx. *Abbrev.* Ac.

Altostratus Clouds Striated or fibrous veil, more or less grey or bluish in colour, appearing between 6,500 and 18,000 ft. approx. The sun or moon may show vaguely through them. *Abbrev.* As.

Aluminium Bronze An alloy of copper, iron and nickel usually used for normal sized propellers of ships.

Always Accessible or Reachable on Arrival A Charter Party, q.v., term in respect of the loading and/ or discharging position when berthed which must be accessible without difficulty. *Abbrev.* AARA or A.A.R.A.

Always Afloat or Always Safely Afloat A charterparty clause which stipulates that the ship is to berth for loading or discharging without touching the bottom of the sea/river/lake, etc. In many cases owners may agree that the vessel can touch on harmless ground whenever low tides occur. *Abbrev.* a.a. *See* **Floating Clause** which is similar, *also* **Sitting Aground**.

American Clause A marine insurance clause referring to double insurance which is usually inserted in American insurance policies. In the event of such a claim, the underwriter who effected the insurance is responsible for meeting the claim. If unable to do so, the second underwriter will have to cover this liability instead, in part or in full, whichever the case may be.

American Cloth Textile with a glazed coating.

American Club Similar to American Steam-Ship Owners Mutual Protection and Indemnity Association, q.v.

American Selling Price A United States method of assessing import duty. Duty is paid on a value arrived at by comparing prices at which the article(s) are already offered in the domestic market. *Abbrev.* ASP.

American Steamship Owners Mutual Protection & Indemnity Association Inc. Popularly known as The American Club. It services its client shipowners both in America and abroad. Originally established in 1917 as a non-profit Mutual Club or P. & I. Club in the United States. Its functions were then restricted to US clients but by 1973 it had developed into an international club with members all over the world. All administration and daily claims are handled by personnel of the Shipowners Claims Bureau Inc., considered to be the oldest Mutual Club and Insurance Underwriters in the United States. *Abbrev.* ASOMPIA.

American Stock Exchange A voluntary incorporated association originally called the New York Curb Exchange until 5 January 1953. Its members are regular stockbrokers engaged in the free sale and purchase of all types of securities, varying from industrial and commercial to railway shares. See New York Stock Exchange; Curb Market; Street Market.

American Tanker Rate or American Tanker Rate Schedule The rates of freight applicable to oil tankers on the main world routes. Started in 1956 and revised periodically, these rates are usually quoted in US currency. In 1963 the International Tanker Normal Freight Scale Association Ltd., *abbrev. Intascale*, was formed and it collaborated on the 1969 World Scale.

American Waterways Association or American Waterways Operators

Every day more than 2,600 vessels worldwide participate in the AMVER Safety Network.

The heart of the AMVER system is a computergenerated data base that in 1993 plotted the voyages of more than 14,416 ships. Voyage information such as time of departure, destination, turn points, radio call sign, medical personnel and other relevant data are transmitted to the computer facility in Martinsburg, West Virginia. The computer can dead reckon the locations of AMVER vessels in relation to a distress signal, as well as indicate their direction of sailing. This gives rescue planners a 'real time' window on the high seas around the world, providing information which enables rescue authorities to make decisions rapidly and with confidence. In 1993 the AMVER network was directly responsible for saving more than 126 lives.

Maximum participation is vital to AMVER's support of search and rescue around the world. The more ships enrolled in the system, the better the chances of emergency assistance being quickly located and dispatched to a vessel in distress. A network of 130 coastal radio stations worldwide relay AMVER position reports from participants at no cost. AMVER information is available only to recognized search and rescue agencies around the world.

Anchor Ball or Black Ball A black ball or circular shape, not less than 0.6 metre in diameter on a vessel 20 metres or more in length, which is hoisted in the fore part to show that she is at anchor.

Anchor Berth Designated position for a ship to anchor.

Anchor Buoy A buoy connected by a line or pennant to an anchor to mark the latter's position, and used sometimes to assist retrieval of the anchor.

Anchor Cable Chain, wire or rope connecting a vessel to her anchor or anchors. See Anchor. Also termed Anchor Chain, q.v.

Anchor and Chain Clause A marine insurance clause not commonly used, freeing the underwriters from expenses to recover lost anchors and chains.

Anchor Chain Similar to Anchor Cable, q.v.

Anchor Currency A dominating currency within the European Monetary System, e.g. the German Mark.

Anchorage A place where ships may be anchored or berthed.

Anchor Detail A vessel's crew members whose responsibility is to operate her anchor-handling equipment.

Anchor Dredger Gravel dredger which pumps aggregates from the seabed and shifts its position as required using her anchors.

Anchor Lights A light shown all around the horizon between sunset and sunrise and during other times of poor visibility to indicate that a vessel is At Anchor. During daylight an Anchor Ball or Black Ball, q.v., is shown.

In general a bulk cargo whose angle of repose is less than 35 degrees needs levelling out or trimming to reduce the risk of the cargo shifting and thus ensuring that the ship remains seaworthy during the voyage. The smaller the angle of repose the more the cargo is liable to shift.

Annuitant An individual who receives an annual lump sum of money for a fixed period of years or for a lifetime. See Annuity.

Annuity A sum of money advanced every year or paid by instalments for a period of time. Life assurance is a case in point. A person can buy a life policy by paying a premium per year. In return he is assured of a substantial sum per year or a lump sum after a fixed number of years. In the event of his death before fulfilling all his premium payments his relatives or testators are assured of the payment of annuity agreed upon before his death. See Assurance.

Annus mirabilis Latin—Year of Wonders —applied to 1666 (year of plague, fire of London) etc.

Anode The electrode at which oxydisation occurs which is the positive pole of an electronic cell but this will be the negative part of a battery. In the case of preventing wear and deterioration of metal zinc is oxidised and this protects the steel with which it is in contact. Zinc plates or anodes are invariably attached to various parts of the underwater sections of a ship to protect against wear, including the propellers and propeller shafts. Arranged Total Loss or Compromised Total Loss Whenever the insured article has suffered a substantial loss, but not to the extent of an apparent actual or constructive total loss, there may be a possibility that the underwriters and the assured mutually agree to settle the claim on a Total Loss basis. *Abbrev.* ATL or A.T.L. or Arr. T.L. and CTL or C.T.L.

Arrears Bills or moneys which are due but have not as yet been paid.

Arrest or Restraint of Princes, Rulers or Seizure under Legal Process An excepted peril of the sea in the Carriage of Goods by Sea Act 1924, amended in 1968 and 1971, in relation to government restrictions, Royal Proclamations and the like.

Arrest and/or Seizure An official order of arrest or seizure of a ship, empowered by the state authorities, for contravening the laws of a country or to exercise a Maritime Lien, q.v, on a ship. The word seizure has a stronger meaning than arrest as it may be interpreted to be a forcible possession by an overpowering force or by the authority of a state. See Seizure.

Arrestment A legal Scottish term in connection with the stoppage of any money transaction until the money owed has been settled by the debtor.

Arrival Notification Form Notification in writing to the consignee/s of the arrival of merchandise. *Abbrev.* ANF.

Arrival Pilot Station. A Time Charterparty term. A vessel is considered to be delivered to the charterers as soon as she has arrived at the pilot station, irrespective of bad weather. A drawback for the charterers. *Abbrev.* APS.

Arrived Ship A shipping phrase in conjunction with the agreed terms of the Charterparty, q.v. A ship has 'arrived' when she is within the precincts of the port. This phrase is regularly inserted in charterparties.

Where the clerk is at the date of the articles under age, his parent or guardian is usually made a party to the articles as well as himself.

Articles of Association Any seven or more persons (or, in the case of a private company, any two or more persons) may, by subscribing their names to a memorandum and otherwise complying with the statutory requirements as to registration, form an incorporated company with or without limited liability. Whatever be the kind of company which is formed, the memorandum must state (a) its name, (b) whether the registered office is to be in England, or Scotland, and (c) its objects; and every subscriber must subscribe it, if it has a share capital, with the number of shares he takes. If liability is limited, by shares or guarantee, that fact must by stated. Articles of association are regulations for the management of a company. The articles are freely alterable by special resolution. See Memorandum of Association.

Articles of Partnership A detailed documented contract setting out the individual responsibility of the active partners of the company. The articles can be altered by agreement among the partners.

Articulated Tug Barge A tug-barge combination system capable of operating on the high seas, coastwise and further inland. It has been so well designed that it has proved to be seaworthy in waves of 30 ft. and over. It combines a normal barge, with a bow resembling that of a ship, but having a deep indent at the stern to accommodate the bow of a pusher tug. The fit is such that the resulting combination behaves almost like a single vessel at sea as well as while manoeuvring. This system can be compared to the Ocean Going Pusher Barge or Tug Combination or Sea Link System. The barge can be disconnected and left behind in a port for loading and/or discharging. In the meantime the tug can undertake another voyage with another barge sailing either empty or full, thus saving considerable expense and time on such a dual purpose voyage. Abbrev. Artubar.

Artificial Horizon (1) A box or trough part filled with mercury to act as a reflecting surface for the observation of heavenly bodies by sextant when the horizon is obscured, mainly of use in surveying. (2) An aircraft gyro-stabilised instrument displaying pitch and roll movements.

The seller is therefore exonerated from any liability arising from latent defects, but not from hidden defects known by the seller which would have to be reckoned with provided that proof is submitted.

Assets Credits belonging to any individual, firm or association, etc. The actual goods and properties which are in possession can be converted or exchanged into money to make good for any debts incurred by the company or individual. Opposite to Liabilities, q.v.

Assigned Freeboards Minimum freeboards assigned to a ship by an 'assigning authority' (usually the state shipping authority) after satisfactory drawings and plans have been produced, a load line survey passed and stability tests completed to the authority's requirements. See Freeboard.

Assignee A person appointed by another to do an act in his own right, or to take over rights or title by assignment.

Assignor One who transfers or assigns property to another.

Assignment The passing of beneficial rights from one party to another. A policy or certificate of insurance cannot be assigned after interest has passed, unless an agreement to assign was made, or implied, prior to the passing of interest. An assignee acquires no greater rights than were held by the assignor, and a breach of good faith by the assignor is deemed to be a breach on the part of the assignee.

Assignment Clause A marine insurance clause authorising the transfer of the insurance interests to another by endorsement.

Assisted Into An insurance expression used in towage and referring to towing into the port of refuge. *Abbrev.* Ass.

Association A society the members of which are united by mutual interests or for a common purpose. *Abbrev.* Assn or Assoc.

Assurance or Life Insurance Personal insurance or an assurance of a person during his or her lifetime or in the case of death. There are two types of assurances: (1) Absolute Assurance where the underwriters pay a sum of money in the event of death before the expiration of the policy (2) Contingent Assurance covering the assured's next of kin or those he leaves in his will in case of death before the policy expires or during his lifetime when the policy time expires, in which case the underwriters pay a lump sum of money, with or without bonuses. This is called 'Endowment'. See Life Insurance.

Assurance Mutuelle A French expression meaning Mutual Insurance or Protection & Indemnity, q.v.It has become the practice of shipowners to form a sort of mutual insurance club, often called Protection & Indemnity Club, in which each and every member has to contribute to the upkeep in originating and paying out claims arising and not normally covered by the insurance policy, such as a quarter of collision liability; payments for legal proceedings in claims for or against; customs fines; cargo shortages; cost of personal accidents etc. Other firms in business such as Shipbrokers and Agents are also forming their own mutual clubs today, covering their members against a wide range of expenses and discrepancies. *Abbrev.* AM or A.M.

At All Times of the Tide and Always Afloat This charterparty clause relieves the ship from waiting in a tidal river or harbour until the tide allows her to proceed to the dock or wharf where she is to load or discharge. The charterer will be required to name a loading or discharging berth where she can lie Always Afloat, q.v., At All Times of the Tide. The clause Always Afloat alone will not justify a vessel in declining to go to a berth when she cannot lie continuously afloat as she can do so partly before and partly after neap tides. So where the ship is chartered to load or discharge As Customary Always Afloat at such a wharf or anchorage, the charterers may direct her to a berth where she can load or discharge part of her cargo afloat, but will then load/discharge the rest of the cargo by means of lighters at an anchorage. That being a customary method of loading in that port, the charterer will commit no breach of contract by using the different methods mentioned.

At Anchor A vessel is said to be at anchor when her anchor is down and holding. When weighing

anchor a vessel continues to be at anchor until the anchor is out of the ground. A vessel moored to buoys may be considered to be at anchor, but a vessel whose anchor is dragged is considered to be 'Under way', q.v.

At and From In marine insurance when concerning cargo this covers the shipped merchandise immediately it is shipped; i.e., at the port and from the port. When concerning the ship it means that the vessel is immediately insured from the port of the commencement of the voyage. If not yet in port, the insurance still operates until she arrives safely irrespective of whether another policy exists. In the case of the insurance being on chartered freight the risk attaches on arrival at the named port.

At Sea In marine insurance this phrase applies to a ship which is free from its moorings and ready to sail.

At Short Notice See At Call.

At Sight This refers to the immediate payment against the presentation of the documents; even with a Bill of Exchange, q.v.

ATT Admiralty Tide Tables.

Attachment The enforcement of a debtor to ensure that he will not dispose of the money or articles in his possession until full settlement is effected. See Arrestment.

Attendance Money Payment to dockers for attending, or standing-by, for work which in the event may not be, or was not, required.

Attention, Interest, Desire and Action Motto for a salesman in his relations with a buyer. Abbrev AIDA.

Automatic Identification System A concept under study (1998) by IMO, q.v., whereby a ship detected on radar can be interrogated and identified when the radar beam triggers a transponder to transmit its Official Number. This number and the interrogated ship's callsign can then be matched to the echo on a radar plot. *Abbrev.* AIS.

Automatic Pilot An instrument designed to control automatically a vessel's steering gear so that she follows a pre-determined track through the water; also applicable to aircraft.

Automatic Selling The selling of goods by means of a coin-operated machine.

Automatic Teller Machine A machine provided at Banks to facilitate withdrawal of money, and other services by using a card. *Abbrev.* ATM. Also called Cash Dispenser.

Automatic Watchkeeper Automatic service on a ship monitoring and supervising the routine working system. This new system eliminates a large amount of normal manual watchkeeping throughout the navigation and also in port.

Autrefois acquit or Autrefois convict Norman French—Previously acquitted or Previously convicted.

Plea of a person accused of the same offence for a second time.

AUV Autonomous Underwater Vehicle.

AUW or A.U.W. or a.u.w. All-up-Weight aviation.

Aux. Auxiliary.

Aux.B. Auxiliary Boiler/s Lloyd's Register notation.

Auxiliary A vessel's machinery, apart from her main engine(s). This may include generators, windlasses, winches, evaporators etc.

Auxiliary Power Unit Aircraft installation to provide heat and ventilation as well as for starting engines, when main engines have been shut down.

Average Partial Loss in insurance. Abbrev. Av. or Avg.

Average Adjuster A person appointed by a shipowner to collect data, guarantees, etc. in relation to general average, and to calculate contributions due from the parties concerned to make good general average losses. The adjuster may also adjust claims on hull insurance policies on behalf of underwriters. See Adjusters.

Average Bond Any extraordinary expenditure or sacrifice of ship, freight or cargo, intentionally and reasonably incurred or made in time of peril, in order to secure the common or general safety of the property involved in a maritime adventure may lead to a claim for General Average. Those who incur such expenditure as well as the owners of any property sacrificed are entitled, subject to the conditions imposed by maritime law and contract, to a rateable contribution from the other parties interested. The apportionment is made by a Statement or Adjustment of General Average which is usually prepared by an Average Adjuster whose appointment rests primarily with the shipowners. The shipowners are entitled to refuse delivery of cargo until adequate security has been provided by the receivers or cargo owners for the payment which shall eventually be found due from each. This security often takes the form of an Average Bond and, in addition, shipowners may demand a cash payment as a deposit in advance, or a Guarantee of the Corporation of Lloyd's, or other approved security.

It is usual for underwriters (although not legally liable to do so) to refund to their assured any amounts thus deposited if Lloyd's Form of General Average Deposit Receipt is used and the funds have been deposited in a special account in a Bank. On completion of the General Average Statement the underwriters then claim any sum by which the amount deposited may be found to exceed the actual liability. The Deposit Receipt is produced in proof of the claimant's right to a refund. It is essential that Deposit Receipts are carefully safeguarded as the issue of duplicates is undesirable. Lloyd's Form of General Average Deposit Receipt is a bearer document and does not require endorsement.

In cases where, owing to the nature of the average expenditure or sacrifice as, for example, where a ship is towed or assisted and a salvage award or settlement has yet to be arrived at, or where damage to a probably serious extent has been caused by flooding the hold to extinguish a fire, but the extent of the damage cannot yet be ascertained-it is sometimes necessary for the shipowners to collect as a deposit from the cargo interests who have benefited from the expenditure or sacrifice a sum which may eventually prove to have been over-estimated. In order to avoid such collections, and as a convenience generally, Lloyd's has a system, applicable to insured cargo, under which the Guarantee of the Corporation of Lloyd's may be given in a form acceptable to shipowners in lieu of a cash deposit.

The Guarantees of the Corporation of Lloyd's are issued in London by the General Average, Salvage and Collision Section at Lloyd's, which, together with the Recoveries against Carriers Section, also acts for insurers in the exercise of their subrogation rights, and in General Average and Salvage cases investigates their rights and liabilities, on receipt of Deposit Receipts, documents of title, or details of any undertaking or security which has been provided to shipowners or to salvors by cargo interests.

Lloyd's Form of General Average Deposit Receipt and Lloyd's Average Bond Forms (LAB 77) with a detachable Valuation Form can be obtained from the General Average Section of Lloyd's Underwriters' Claims and Recoveries Office.

Lloyd's Average Bond was completely revised in 1977 and the code title LAB 77 is incorporated to facilitate reference in telegraphic messages and computerised documents. The form produced at Lloyd's consists of two pages. The top page is the Average Bond part and the bottom page is for recording the

value of the goods received. The particulars common to both pages coincide, so that by the use of a sheet of carbon only one typing is necessary. The completion and return of the Average Bond part of the form may result in the early release of the goods and when their condition has been ascertained the information asked for in the bottom page (the Valuation Form) should be provided together with a copy of the commercial invoice to assist the Average Adjuster to draw up his Statement or Adjustment promptly. See also Average Statement and General Average Deposit. Abbrev. a,b. or AB or A.B.

Average Clause A marine insurance clause whereby the insurers or underwriters are liable to certain perishable goods in Particular Average either in part (percentage) or in all. The Memorandum of Marine Insurance, see Memorandum, refers to the Average Clause where certain commodities are insured over a percentage of say 5% franchise unless of course the vessel is under a General Average act where the full amount is accepted for payment by the underwriters or insurers. Ex. of these commodities are: Flax, fish, hemp, hides, skins, sugar, tobacco and other perishables.

Average Cost The total expenses of production in a period of time divided by the unit number.

Average Damage Affecting Class This is generally a condition applied on the delivery of a vessel on charter whereunder the owner is committed to keeping his vessel within her society class, fully maintained, free of all recommendations, and free of average damage which could affect her class.

Average Demurrage The agreement in a charterparty for despatch money due to the charterers. See Despatch Money and Despatch Days, q.v.

Average Deposit See General Average Deposit or Average Bond.

Average Disbursements Expenditure incurred by the shipowner in connection with a general average act or an act of salvage. Such expenditure, when properly incurred, is recoverable from the G.A. or salvage fund created by the average adjuster, not from hull underwriters.

Average Due Date The average date arrived at from outstanding money due from various dates. See Equated Time.

Average Freight Rate Assessment First created by the London Tanker Brokers' Panel in 1954 as an independent assessment of international tanker shipping rates. Since 1959, it has been a monthly calculation of average rates for all chartered tankers in six size ranges. Product carriers and protected cabotage tonnage are excluded. The AFRA, taken as shipping cost, when added to the FAB cost of oil, can be used in negotiating import price.
