TABLE OF CASES

To find the text of a case the most important piece of data is the case number, which enables the judgment and other documents to be found on CD-ROMs or the Europa website (www.europa.eu.int). Remember to use the C- or T- prefixes for Court of Justice or Court of First Instance judgments respectively only if they date from 1990 or later.
